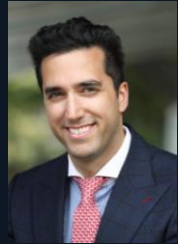
Industry & Finance Keynote

Ken Sim



Ken Sim launched Nurse Next Door in 2001, which has since opened franchises in 180 cities across North America, employing more than 5,000 staff. Before that, Ken worked in the financial sector including at CIBC World Markets and CIBC Capital Partners. He was recognized as EY's Entrepreneur of the year in 2006 and Business in Vancouver's Top 40 under 40 in 2005. Ken holds a Bachelor of Commerce from the University of British Columbia. In 2018, Ken was nominated by the NPA to lead the party in the Vancouver mayoral election and came in second place by a narrow margin of less than 1,000 votes.

Kia Besharat



Kia Besharat is a Senior Managing Director & Head of Capital Markets Origination at Gravitas Securities. He is also a founder and shareholder in global private equity funds and hedge funds. Kia started his career in private equity and became involved in deal origination early on at Ubequity Capital, where he became a Managing Director. He later joined Gravitas Securities to establish their Western Canada advisory practice and led transactions in cannabis, consumer/retail, oil & gas, internet/new media, technology and healthcare. He competed in professional tennis before pursuing a career in finance.
